This is due to the omission of absent students from the calculation of the percent at or above proficient. If a school does not have the required 95 percent participation with 40 or more students, it will not have made AYP, regardless of the subgroup size for the percent at or above proficient calculation.

² For any school or subgroup that did not meet the 95 percent participation rate criterion, a two- and three-year average participation rate using 2007, 2006, and 2005 CAPT is calculated. If the two-year or three-year average was greater than the current participation rate, it was used for the AYP analysis.
